



Remarks by
His Excellency the Director-General

The year 2019 was exceptional. It was the year the Abu Dhabi Chamber celebrated its Golden Jubilee. It was a year full of achievements, initiatives and representation of the private sector.

The publication of the annual report of the Abu Dhabi Chamber comes in line with this great anniversary to highlight the activities and events the Chamber held in 2019 with the aim of strengthening the partnership between the public and private sectors and to move forward towards realizing the sustainable economic development according to Abu Dhabi Economic Vision 2030.

In 2019, the Abu Dhabi Chamber took a number of initiatives aimed at the private sector including widening its contacts network and informing about the benefits of being a member of the Chamber.

Last year, the Chamber registered an increase in the number of its members to reach 114,000 including 99,000 active members. The number of renewed memberships stood at 79,523, new ones at 19,402, canceled ones were 118 and inactive ones were at 15,850 memberships.

In addition, the Abu Dhabi Chamber organized 50 events including 1 conference, 30 orientation seminars, 4 celebrations, and 15 different activities through which it aimed at informing businesses with the available investment opportunities in the local and international markets. The Chamber also conducted a number of workshops aimed at businesses in order to enhance performance and increase their productivity.

The Chamber also received 28 visiting trade delegations and organized 4 out-bound trade delegations whose main job was to discuss economic, trade and investment cooperation relations with a number of friendly countries.

The Chamber took part in diverse activities and events as well. It participated in 7 conferences and exhibitions locally and internationally, which comes within the awareness and efforts of the Chamber to promote for Abu Dhabi as an attractive investment destination in the region, and to introduce foreign investors to the available investment opportunities in the emirate.

Within its efforts to strengthen its partnership with different governmental entities, the Chamber signed a number of memorandums of understanding and cooperation agreements aiming at facilitating the business of companies and providing a competitive business environment in the emirate.

The subsidiaries of the Chamber namely the Sheikh Khalifa Excellence Award Office, Abu Dhabi Center for Corporate Governance, Abu Dhabi Commercial Conciliation and Arbitration Center, UAE Academy, and Abu Dhabi Businesswomen Council made considerable advancements in 2019 as well. They were busy conducting a number of orientation seminars, workshops and training programs for businesses from different sectors in Abu Dhabi. The Abu Dhabi Commercial Conciliation and Arbitration Center held 6 training programs to habilitate and prepare arbitrators and settled 74 commercial disputes; whereas the Sheikh Khalifa Excellence Award Office organized a number of training courses in which 1,031 people and 221 public and private entities took part.

The UAE Academy conducted 212 training programs in 2019 which 1,798 trainee from 57 public and private companies taking part; whereas the Abu Dhabi Businesswomen Council organized 60 events including the 5th Entrepreneurship Awareness Campaign. In addition, the council has issued 774 Mubdiaa licenses; whereas the number of businesswomen who joined the council reached 230 businesswomen and women entrepreneurs.

In conclusion, I would like to express my utmost appreciation and praise to all the employees of the Abu Dhabi Chamber who worked hard and effortlessly to perform their duties and responsibilities. We pledge to keep on providing the best service there is for businesses in Abu Dhabi and to strengthen their partnerships with the public sector to increase their role in the sustainable development process under our wise leadership.

## Abu Dhabi Chamber's Sectors' Committee

#### **Summary on Abu Dhabi Economic Performance in 2019**

Despite the fluctuations in the world economy over the past few years, but the economy of Abu Dhabi has proven its resilience considering the flexible financial policies and strength of the local economy of the emirate. This is evident in the second and third quarters of the 2019 quarterly reports of the national accounts, which revealed considerable GDP growth in Abu Dhabi according to the Statistic Center – Abu Dhabi. <sup>1</sup>

According to the results of the quarterly economic survey, Abu Dhabi's GDP at constant prices increased 2.7% to AED 204.9 billion in Q3 of 2019, up from AED 199.5 billion for the same quarter of 2018. In Q2 of 2019, Abu Dhabi's GDP at constant prices increased by 5.2% to AED 207.7 billion, compared to AED 197.4 billion for the same period in 2018.

Data also shows positive growth in oil sector, and the majority of non-oil sectors.

The business sector has made positive and considerable achievements. The 2019 Business Activity report issued by the Abu Dhabi Business Centre (ADBC) of the Abu Dhabi Department of Economic Development's (ADDED) reveals that the department issued approximately 18,628 new economic licenses in 2019, reflecting a growth of 63.9 per cent as compared to the 11,366 licenses that were issued in 2018. <sup>2</sup>

The report also shows that the number of renewed economic licenses in 2019 reached 80,477 licenses, demonstrating the business sector's rapid growth pace and the confidence of investors and businessmen in Abu Dhabi's thriving business environment.

The number of industrial facilities operating in Abu Dhabi grew by more than 57 per cent in 2019 to reach 66 facilities – recording a combined investment value of AED 6.29 billion - as opposed to 42 facilities in 2018, according to the latest edition of the annual Industrial Activity report issued by the Industrial Development Bureau (IDB) of the DED.<sup>3</sup>

At the level of the four banks listed on the Abu Dhabi Stock Exchange, its profits amounted to 18.95 billion dirhams during the past year, a growth of 3.7% compared to 18.273 billion dirhams in 2018. 4

There are many elements to support the economy of Abu Dhabi starting with focusing on developing a knowledge economy built on innovation and creativity within the strategy of economic diversity, supporting and financing SMEs and acknowledging their role in moving the economy forward.

In addition, there are a number of initiatives that were taken that would help the investment environment grow and increase the role of the private sector in moving the economy. Such initiatives would also contribute to the competitiveness capabilities of the emirate and strengthen the strategic partnership between the public sector and the private one.

#### **Sectoral Committees of the BOD**

A number of BoD sectoral committees were formed considering their role in viewing the current conditions of the private sector, its problems and challenges, and in founding proper and practical solutions, conducting specialized economic studies to develop the different sectors of the private sector.

The membership of the BoD sectoral committees includes a number of the Chamber's Board Members, businessmen, and members of the Chamber from different sectors in addition to members from different public entities.

#### The aim behind forming the BoD sectoral committees is to:

- Strengthening the bonds between the Chamber and its members through introducing them to the services of the Chamber and the role of the committees in this regard.
- Specifying the challenges the private sector face and presenting their recommendations to the related authorities.
- Working on improving the performance businesses by organizing annual forums, seminars and workshops.

- Activating the partnership between the public sector and the private one in order to increase the participation of the latter in the projects of the government (BOT, PPP).





#### Firstly: Chamber's Membership Turnover from 2016 – 2019





ADCCAC aims to resolving national and international commercial disputes according to procedures that meet the needs of investors, in line with the established rules in modern arbitration, and aim to publicize the arbitral awareness within the business community.

ADCCAC offers its services and facilities to the disputing parties in order to manage the arbitration process under the best conditions; providing that it supervises the implementation of conciliation and arbitration systems throughout administrational and organizational services for the disputing parties. The Center also provides lists of arbitrators, experts, conciliators and translators from all specializations, organizes conferences, seminars and workshops, provides information on arbitration and prepares studies and specialized researches in arbitration in addition to other services.
